### ACKNOWLEDGMENT, RELEASE, HOLD HARMLESS AND ASSUMPTION OF POTENTIAL RISK AGREEMENT.

I hereby release, discharge, indemnify, and agree to hold harmless the VEYS Northeast Region, its governing board, and its representatives free from any and all liability arising out of or in connection with my participation in Betania IX, including all related activity such as games, practices, training activities, trips and related exercise. For purpose of this RELEASE, liability means all claims, demands, losses, causes of action, suits, or judgments of any kind that my or my parents, guardians, heirs, executors, administrators, and assigns may have against the VEYS Northeast Region, its board, and its representatives because of my personal, physical or emotional, injury, accident, illness, or death, or because of any loss of or damage to property that occurs to my property during my participation in Betania IX that may result from any cause including but not limited to VEYS Northeast Region', its board', and its representatives' own passive or active negligence or other acts other than fraud, willful misconduct or violation of the law.
